- 2. It is up to the Legislature and the Courts to determine the scope of Missouri's statutory and constitutional authority to my knowledge, the Missouri courts have not ruled on this issue and therefore Missouri's laws on immigration are the law of the land and must be enforced as I said before, I will abide by and act to enforce all Missouri laws.
- 3. The Legislature is tasked with setting forth in law the parameters it believes are necessary to protect Missouri citizens and their wages again, I will enforce all Missouri laws including, but not limited to any existing or new laws adopted that protect Missouri's citizens and their wages.
- 4. All policies of the Department of Economic Development and the enforcement thereof will be in conformance with state law, including those that relate to limitations on state-funded benefits.
